CALL TO ORDER:

The Council of the City of Lima met in regular session at 7:00 p.m.

President Dixon reserved 39 seconds of silence in memory of former President Jimmy Carter.

INVOCATION AND PLEDGE ALLEGIANCE:

The invocation was given by Councilor Gordon followed by the Pledge of Allegiance.

REPORTS OF OFFICIALS:

Major Ron Holman provided Council with an update on the Lima Police Department traffic trailers. He advised that in 2024 the Lima Police Dept. deployed two of their All Traffic Solutions Trailers for just over 30 times for 427 days total between the both of them. He advised the City was able to track almost 1.6 Million vehicles in 2024. He explained the nice part of having the traffic trailers is once they receive a complaint, they can deploy the trailers relatively quickly and obtain data which makes their allocation of man power much more effective.

013-25 An Ordinance authorizing the Mayor to enter into contract with Midwest Air Power LLC for the Wastewater Treatment Plant.

Glenn moved, seconded by Neeper, that the ordinance be passed on the first reading. The following roll call vote was recorded on the motion: Yea, 7; Gordon, Jordan, Thompson, Dixon, Jones, Glenn, Neeper. Nay, none. The Chair declared the ordinance passed on the first reading by a 7-0 vote.

015-25 An Ordinance authorizing the Mayor to sell real property located on Hughes Avenue to Dorothy Peterson and Marsha Beasley.

Glenn moved, seconded by Neeper, that the ordinance be passed on the first reading. The following roll call vote was recorded on the motion: Yea, 6; Gordon, Jordan, Thompson, Jones, Glenn, Neeper. Nay, none. Abstention, 1; Dixon. The Chair declared the ordinance passed on the first reading by a 6-0 vote with 1 abstention.

MISCELLANEOUS BUSINESS:

Gordon moved, seconded by Thompson, to authorize the absence and salary for Councilor Wilkerson. Motion carried.

Councilor Gordon referenced the incident that took place in the City of New Orleans and explained it is important to look at the individual who caused the accident rather than point fingers at the City. He explained the City of Lima is blessed with a great Police Dept., Fire Dept., and Administration. He reminded people to be good to each other.

Councilor Thompson announced the Central Lima Neighborhood Association will meet on January 22, 2025 at 6:00 p.m. at the Lima Public Library. She further announced there will be a Cafe Convo at St. Rita's Medical Center on January 15, 2025 at 6:00 p.m. in the Cafeteria. She encouraged everyone to purchase a ticket for the MLK Breakfast on January 20, 2025.

Councilor Jordan announced that CUP Food Pantry is looking for a volunteer Director or some people to be on their leadership team and to contact her for additional information if interested.

Councilor Jones referenced Major Holman's presentation which put him in the mindset of all the issues that the City has been having with the topic of traffic calming. He believes the Mayor and her administration are doing a great job of staying on top of the traffic calming issue and ensuring we come up with a solution. He referenced the phone calls he receives regarding traffic and it makes it easier hearing exactly what is going on so he can communicate the information with his constituents.

Councilor Glenn thanked the residents who got on him about different issues going on in his Ward. He expressed his appreciation to the President for bringing up specific topics during the Pre-Council meeting. He expressed the importance of seeing improvement and encouraged residents to continue loving their neighborhoods. He expressed how happy he is for the calendar in memory of Malik who was murdered. He announced there will be a coat drive held from 3pm to 6pm every Tuesday and Thursday at Providence Missionary Baptist Church and encouraged the public to donate. He announced there will be a second Mental Health Town Hall Meeting at Providence Missionary Baptist Church on January 12th from 4pm to 6pm. He announced he is working with Faith Christian Church to give the kids a meal every Thursday starting later in February. He announced the 43rd annual MLK Dinner on January 19, 2025 at City Club where they will be giving out awards. He announced he will be holding the MLK March rain or shine starting at 3:00 pm on Monday, January 20, 2025. He advised they will be having another landlord meeting at the Wingate Hotel on March 12, 2025.

Neeper moved, seconded by Glenn, to refer the issue of Certificate of Occupancy for renovated properties to the Council of the Whole Committee. Motion carried.

Councilor Neeper expressed his gratitude to the various groups in town as he had the privilege of attending various events including the Lima Symphony who put on a fantastic show as always.

Neeper moved, seconded by Glenn, to authorize a resolution of appreciation to the owners of the Ohio Theatre. Motion carried.

Dixon moved, seconded by Jones, to appoint Peggy Ehora to the Civil Service Board. Motion carried.

ADJOURNMENT:

Gordon moved, seconded by Thompson, to adjourn until January 27, 2025. Motion carried.
