Betsy Billingsley, Executive Dir. of Visit Greater Lima, provided Council with the Visit Greater Lima 2024 Annual Report. She expressed appreciation to Christine Pleva who retired in May after 23 years of service. She also expressed appreciation to Sharree Brenneman-Reehling who retired in June after 38 years of service. She expressed the Eclipse event was amazing as they distributed over 7,000 glasses to various individuals and the hotels were full. She introduced Visit Greater Lima's new online storefront where various apparel and accessories can be purchased and the proceeds will go towards the Destination Development Grants. She referenced the various types of advertisements Visit Greater Lima has done in the last year. She advised there were 9 Destination Development Grants totaling approximately \$67,000.00 awarded to local non-profit organizations within Allen County in 2024. She advised there were 2 First Timer Grants awarded and 2 Retention Grants awarded in 2024. She referenced the various marketing platforms used and advised there was a 119% increase. She explained the Geo Catching Trail is still going strong as they are seeing visitors from all over the United States. She expressed Visit Greater Lima strives on increased tourism and through that economic development which they hope to continue with some of the latest

programs as they are changing a few things to reach more people in 2025. She thanked Council for their support.

Ric Stolly, Dep. Dir. of Parks and Recreation provided Council with a wrap up of the fall and winter activities in parks and recreation. He recognized the Maintenance Supervisor, Keith Monford, who did a great job with his staff ensuring people are safe. He referenced the parks involvement in leaf removal in the winter along with snow removal in the winter. He advised in 2024 they put together 30 new picnic tables that you will see disbursed throughout the various parks in the City. He reviewed the various winter recreation programs including the youth basketball program and youth WOYBL League. He referenced the various local schools that were district champions all have students who were involved in the City's youth basketball program. He expressed the youth programs have helped the high school sports experience at the high school level a little bit better. He explained the success of the City programs is not possible without the support of City Council, the vision from the Administration and having a staff that is committed and has a passion for the development of the children in the community.

He expressed at the end of the day, the approval of who is in that role is with the City. He explained the employment of lifeguards and other part time staff is through grass roots marketing through the local community. He explained there will be routine training programs which will ensure growth within the employees. He explained Sports Facilities Management currently operates 78 venues throughout the country so there is room for growth for employees within the organization. He advised the cost of admission has not been finalized and those rates will be a collaborative effort between Sports Facilities Management and the City. He referenced the various types of local activities that can be done to bring a unique experience for everyone.

She referenced the various types of advertisements Visit Greater Lima has done in the last year. She advised there were 9 Destination Development Grants totaling approximately \$67,000.00 awarded to local non-profit organizations within Allen County in 2024. She advised there were 2 First Timer Grants awarded and 2 Retention Grants awarded in 2024. She referenced the various marketing platforms used and advised there was a 119% increase. She explained the Geo Catching Trail is still going strong as they are seeing visitors from all over the United States. She expressed Visit Greater Lima strives on increased tourism and through that economic development which they hope to continue with some of the latest

programs as they are changing a few things to reach more people in 2025. She thanked Council for their support.

Ric Stolly, Dep. Dir. of Parks and Recreation provided Council with a wrap up of the fall and winter activities in parks and recreation. He recognized the Maintenance Supervisor, Keith Monford, who did a great job with his staff ensuring people are safe. He referenced the parks involvement in leaf removal in the winter along with snow removal in the winter. He advised in 2024 they put together 30 new picnic tables that you will see disbursed throughout the various parks in the City. He reviewed the various winter recreation programs including the youth basketball program and youth WOYBL League. He referenced the various local schools that were district champions all have students who were involved in the City's youth basketball program. He expressed the youth programs have helped the high school sports experience at the high school level a little bit better. He explained the success of the City programs is not possible without the support of City Council, the vision from the Administration and having a staff that is committed and has a passion for the development of the children in the community.

He explained Sports Facilities Management currently operates 78 venues throughout the country so there is room for growth for employees within the organization. He advised the cost of admission has not been finalized and those rates will be a collaborative effort between Sports Facilities Management and the City. He referenced the various types of local activities that can be done to bring a unique experience for everyone.

Councilor Glenn announced the Human Resources Committee will meet on Monday, March 17th at 6:00 pm. He presented Councilor Neeper with the Furl Williams Award as he was not able to attend the Martin Luther King Jr. Day Award Ceremony. He explained Neeper and his wife support Lima and are very involved in the community. He advised Councilor Thompson received the Mary Coleman Award. He referenced a meeting he attended regarding trailers which he appreciates because he's excited to see everyone involved in keeping the City clean.

Councilor Neeper reminded everyone it's getting warm out so be mindful when driving as kids will be out playing. He referenced the local basketball teams and expressed the City is very fortunate as we have some great talents from all schools.
